25/26/016 Public Participation Period

- i) There is still an ongoing issue with a dog roaming the village. The Parish Council has contacted the dog warden, and it was suggested to notify the Police. Action: The Clerk to make contact.
- ii) The village is looking untidy, and the grass verges at the junctions of Coombe Keynes and New Buildings need to be trimmed back, as they are making the turns extremely dangerous. A member of the public has reported this issue on the Dorset Council Portal. **Action**: The Clerk will report this and request completion before the Camp Bestival setup.
- iii) There have been house parties at both the Lindens and Woodside, leading to a significant number of vehicles parking on the road and around the Triangle. This could pose access challenges for emergency services if they needed to respond to a call in that area. The Lindens do have additional parking available, but Woodside would need to reserve the field for extra space. **Action:** The Parish Council to contact the Estate.

b) Community Speedwatch

In the past few weeks, 20 vehicles have been caught speeding. Motorists in Dorset who have been caught exceeding 50 mph in a 30 mph zone face a visit from the police. The company managing the logistics is required to record three checks on a daily basis, to ensure that the signs displaying the temporary speed limit are up; however, this has not been done. As a result, there has been some uncertainty on this procedure as some drivers caught speeding may claim that there was no signage indicating the speed limit therefore, the Speedwatch programme cannot be operated at the time.

The Speedwatch team are able to monitor traffic before the Road Traffic Orders take effect. The police have expressed surprise that the speed limit does not extend all the way to Coombe Keynes. It has been suggested to reach out to the Coombe Keynes Parish Meeting and the Equestrian Centre to seek their support for extending the speed limit.

c) Speed Indicator Device

Cllr Barnes has sent an email to the Speed Indicator Device Team.

d) Road Markings

It was hoped that the markings would be completed at the same time as the resurfacing. Cllr Barnes has contacted the Road Safety Technical Officer, who clarified that the road markings are considered a separate project and will be carried out by an external contractor. This work is scheduled to take place within this financial year. However, the contractor has a considerable number of sites across the county awaiting lining, particularly in locations with a history of injury collisions, therefore those sites take priority.

e) Signage Improvement

Cllr Barnes requested that if anyone sees a deer carcass located between the garage and Botany Farm, they should report it on the Dorset Portal to ensure it is recorded. Additionally, the Road Safety Officer has met with the Signage Team to request the installation of horse and deer warning signs.

on Thursday 17th July, from 6-7pm in the Harness Room, Lulworth Estate. **Noted.**Proposed Temporary Traffic Management Order - Camp Bestival. The first Order will effect a safe traffic management plan for ingress and egress, and will minimise the disruption caused by the event on the highway network. This will create additional ingress routes, temporarily reduce the speed limits, and extend the existing clearway around East Lulworth village and the entrances to the event car parks. The second Order will temporarily close footpaths through the event site for safety and security reasons. **Noted.**

a) Natural England aims to publish its proposals for the King Charles III England Coast Path between Lulworth Cove and Kimmeridge.
