#### **20/21/043 Public Participation Period**

##### **b) Other Issues**

i) There is a large pothole approximately 9" wide by the Tyneham turning, near the Monastery Farm Gate. **Action:** The Clerk to report it online.

ii) On the Army Ranges Warning Sign near the new fingerpost it advises motorists to turn left to go to Wareham instead of using the bypass. It was suggested that the Army should change this to direct all traffic to go right. **Action:** Cllr Barnes to speak to Cllr Weld.

Cllr Barnes will investigate purchasing defibrillators for the telephone box at the Shaggs and the Estate Office. **Action:** The Clerk to forward information on defibrillators to Cllr Barnes.

#### **20/21/051 Camp Festival**

Cllr Pinnock attended the Community & External Partners Meeting on 18th February. The site layout would be the same as the last event except that the field behind the Weld Arms would be used during the festival period for disabled ticket holders. We will be advised nearer the time on the access route to the festival ground. Rob da Bank reported that current ticket sales were 13500 which includes rollover tickets from last year. The residents meeting is provisionally booked for 22nd June in the Courtyard.

#### **20/21/052 Correspondence**

- b) Census 2021 is coming. The national census is due to take place in March. **Noted.**
- c) DAPTC E-News 29th January '21. Information includes Dorset AONB request details of footpath degradation and the Section 137 Expenditure Limit set for 2021/2022 is £8.41. **Noted.**
- d) Camp Bestival 2021 - Community & External Partners Meeting. This took place on Thursday 18th February. **Noted.**
- e) Temporary Traffic Regulation Order for Woolbridge Roundabout. The road will be closed for resurfacing from 9:00am Friday 23rd April to 6:00am Monday 26th April. **Noted.**
- f) NEWS: Household recycling centres once again straining under increased visitor numbers. Do not visit a household recycling centre (HRC, or “the tip”) right now unless your waste cannot be stored safely at home. This is the simple message that Dorset Council is using to help deal with rising visitor numbers. **Noted.**
- g) Covid-19 Message from Assistant Chief Constable To Communities In Dorset. While people are allowed to leave home to exercise, the Government is asking the public to stay local when doing so. This means staying in your village or town and not travelling further to other areas because you’d like to visit your favourite beauty spot. **Noted.**
- h) Car park Notices. The extended morning charges in Purbeck to begin at 8am on 1st April. There will no longer be two free hours of parking in Wareham.

- a) Community Governance Review (CGR) of all town councils, parish councils and parish meetings that sit within the Dorset Council area. Dorset Council are required to undertake a review of governance arrangements of all parishes every 10-15 years, and as a number of tentative enquiries have been made, now seems the right time to carry out a council-wide review. **Noted.**
- b) Former St Mary's School site, Shaftesbury. Dorset Council is seeking your views on its idea to create a new school for children with special educational needs and disabilities (SEND) on the former St Mary's School site in Shaftesbury. This consultation runs from Thursday 4 February to Thursday 18 March 2021. **Noted.**
